# 'Focus on protecting member' interests and achieving financial sustainability'

Hastings Co-op introduced two new Directors and applauded the dedication of "our resilient, hardworking" staff at today's Annual General Meeting.

Highlights of the 2022/23 financial year included: welcoming new Chief Executive Officer Nick de Groot; a 15% increase in Co-op 100 members; returning \$385,395 in rewards vouchers to Shareholders and Co-op 100 members; donating \$12,000 in Community Chest grants and; winning nine major business awards at local, regional, state and national levels.

The community owned co-operative, which employs more than 300 locals, also sponsored 63 community groups, gained safety certification ISO 45001:2018 and continued to reduce their environmental footprint through solar panels, reduced plastic packaging, increased recycling, offering battery recycling units to customers, partnering with OzHarvest and Billabong Zoo and researching new ways to care for the environment.

CEO Nick de Groot recognised that "there had been major challenges and difficult decisions" in 2022/23, but said he was "buoyed by the incredible team that I work with".

"We will continue to focus on protecting our members' interests and achieving financial sustainability so we can give back to the community," he said.

"More difficult decisions will almost certainly need to be made, but we are committed to acting in the best interests of members, customers and staff."

Chair Gary Humphreys said increasing competition, limited cashflow and significant capital investment requirements posed challenges, but was confident in Hastings Co-op's strengths.

"Our community focus, strong brand, excellent employees and loyal customer base are the foundation for reforming our business and setting it up for future success," he said.

Mr Humphreys thanked departing Directors Jane Evans and Lisa Internann for their "dedicated service and significant contribution to the local community" and welcomed new Directors Leesa Bauer and Louise Eyres (biographies over page).
