

## 2019 \$10,000 Giveaway

### Giveaway Rules and Conditions of Entry

#### 1. The Prizes

- 1.1. The total maximum notional value of the prize pool awarded in this promotion is AUD\$15,000.
- 1.2. The Major Prize is one (1) x Hastings Co-operative charge account to the value of \$10,000 which can be used to purchase goods and services at any\* one of the Hastings Co-operative stores.
- 1.3. Ten consolation Prizes consist of:
  - 1.3.1. Ten (10) x Hastings Co-operative vouchers to the value of \$500 which can be used to purchase goods and services at any\* one of the Hastings Co-operative Stores.

*\*Prize is not redeemable at Caltex Service Station – Bolwarra Road Port Macquarie and excludes the purchase of Cigarettes and tobacco products at all stores.*

#### 2. Duration of Promotion and Entry Period

- 2.1. Entries for the Hastings Co-op 2019 Major Prize Giveaway must be received during the Entry Period. The Entry Period starts at 12.00am on Monday the 4<sup>th</sup> February 2019 (04/02/19), and ends on 29<sup>th</sup> March 2019 (29/3/19) at 8.00pm.

#### 3. Eligibility to Enter

- 3.1. Entries can only be made on Hastings Co-op transaction receipts or account docket where the transaction is for AUD\$40 or more and is made at any Hastings Co-op business during the Entry Period as stated in section 2.1.
- 3.2. There can only be one entry per original receipt or docket (e.g. \$45 purchase = 1 entry, \$182 purchase = 1 entry).
- 3.3. There is no limit to the amount of entries that can be lodged by any individual customer, however only one entry is available per each valid transaction, per original receipt or docket.
- 3.4. Hastings Co-op Public Officer and Directors and their immediate family members are ineligible to enter. Any entries received by Hastings Co-op Public Officer and Directors and any immediate family members of directors will be excluded from the draw and / or excluded from winning\*.

*\*Except family members of Public Officers and Directors who are currently employed with Hastings Co-operative.*

#### 4. Entry into Promotion

- 4.1. Valid entries are made by:

Making a purchase at any\* Hastings Co-op business to the value of AUD\$40\*\* or more and obtaining the original receipt or docket;

*\*Excluding Caltex Service Station – Bolwarra Road Port Macquarie.*

*\*\*Excluding tobacco and tobacco related products.*

  - 4.1.1. Completing on the reverse of the receipt OR on the front of the receipt, where marked, the full name (initials are acceptable) and contact details of the person entering, consisting of a full address AND/OR a contact telephone number;
  - 4.1.2. Placing the original receipt or docket with full contact details of the person entering into the entry barrels located prominently at each Hasting Co-op business marked with the Promotion material.
- 4.2. Entries must be on original receipts or dockets; duplicate copies of receipts or dockets will be invalid and will be excluded from the draw and / or excluded from winning.
- 4.3. If an entry is missing contact details or is illegible, it will be considered invalid and will be excluded from the draw and / or excluded from winning.

## 5. Drawing winning entries, notification of winners and claiming prizes

- 5.1. All eligible and valid entries will be placed in a suitable vessel and will be drawn by hand by a community member independent of the Hastings Co-op.
- 5.2. The Major Prize and the Supplementary Prizes will be drawn on 5th April 2019 during the Timbertown IGA 10<sup>th</sup> birthday celebrations (at a time between 10am and 2pm and to be further announced in the Wauchope Gazette).
- 5.3. In circumstances where the Timbertown IGA 10<sup>th</sup> birthday celebrations event is cancelled for whatever reason, the Major Prize and the Supplementary Prizes will be drawn at 10am on 8<sup>th</sup> April 2019 at the Corporate Office of Hastings Co-operative Limited, Level 1 9-13 High Street, Wauchope NSW 2446 in accordance with section 5.1.
- 5.4. The winner of the Major Prize will be the first drawn eligible and valid entry; the supplementary prizes will then be drawn consecutively.
- 5.5. Should an entry be drawn that is considered to be ineligible under section 3.4 it will be referred to an independent panel of three people comprised of community members independent of the Hastings Co-op who will make the final determination as to eligibility for the prize.
- 5.6. The Winners of all prizes do not need to be present at the draw to claim the prize
- 5.7. As far as practicable, all winners will be notified within 2 days of the draw. All winners will be notified firstly by telephone and secondly by mail using the contact details supplied on the entry.
- 5.8. All winners will be published online at [www.hastingscoop.com.au](http://www.hastingscoop.com.au) by 5pm Monday April 8, 2019.
- 5.9. The winner of the Major Prize needs to claim their prize by arrangement with Hastings Co-op. The winner will receive the Major Prize no later than 6 weeks after the draw.
- 5.10. The winners of the supplementary prizes may claim their prize at the draw, or by arrangement with Hastings Co-op. The winners will receive the prize no later than 6 weeks after the draw.

## 6. Right to Re-draw if Prize is unclaimed

- 6.1. Winners must claim their prize within 3 months of being notified.
- 6.2. If a prize is not claimed within 3 months of being notified, Hastings Co-op will take all reasonable steps to deliver the unclaimed prize to the winner. At the conclusion of 3 months, if the prize cannot be delivered, Hastings Co-op may re-draw the prize, subject to approval and any directions made by the Office of Liquor, Gaming and Racing.

## 7. Prize Ineligibility

- 7.1. If an ineligible or invalid entry is drawn another entry will be drawn until an eligible and valid entry is drawn.

## 8. General Conditions

- 8.1. All eligible and valid entries will be included in the draw.
- 8.2. All prizes are non-transferrable, non-changeable and non-extendable and cannot be exchanged for cash.
- 8.3. Cigarettes and tobacco products including e-cigarette are excluded from this promotion.
- 8.4. Staff of the Hastings Co-operative and their immediate families are eligible to enter this promotion.
- 8.5. The following Co-op businesses are excluded from being able to redeem all or part of the prize pool
  - 8.5.1. Caltex Service Station – Bolwarra Road Port Macquarie
- 8.6. The draw and announcement of the prize winners will be scrutinised by a community member independent of the Hastings Co-op.
- 8.7. Hastings Co-op will use its best endeavours to provide the prizes listed in section 1. If any portion of the prize pool is unavailable for any reason, Hastings Co-op reserves the right to substitute the prize for a prize or item of equivalent value.
- 8.8. Each prize must be as taken as stated and no compensation will be payable if a winner is unable to use the prize. A prize cannot be transferred to any other person unless agreed by the Hastings Co-op. It is a condition of winning the prize that the winner accepts these conditions.
