

## Department Store Annual Sale Days Giveaway

#### **Giveaway Rules and Conditions of Entry**

#### 1. The Prizes

- **1.1.** The total maximum notional value of the prize pool awarded in this promotion is AUD\$1,000.
- **1.2.** The Prizes are two (2) x Department Store vouchers to the value of \$500 each, which can be used to purchase goods and services at any one of the Hastings Co-operative Department Stores.

# 2. Duration of Promotion and Entry Period

2.1. Entries for the Department Store Annual Sale Days Giveaway campaign must be received during the entry period. The entry period starts at 9am on Thursday November 8, 2018 (8/11/18), and ends on Thursday December 6, 2018 (6/12/18) at 5pm.

# 3. Eligibility to Enter

- 3.1. All purchases to the value of fifty (\$50) dollars or over are eligible for an entry during the entry period as stated in section 2.1.
- **3.2.** There can only be one entry per transaction (e.g. \$50 purchase = 1 entry, \$182 purchase = 1 entry).
- **3.3.** There is no limit to the amount of entries that can be lodged by any individual member.
- **3.4.** Hastings Co-op Public Officer and Directors and their immediate family members are ineligible to enter. Any entries received by Hastings Co-op Public Officer and Directors and any immediate family members of directors will be excluded from the draw and / or excluded from winning.

## 4. Entry into Promotion

- **4.1.** Valid entries are made by:
  - **4.1.1.** Make a purchase at any Hastings Co-op Department Store (Wauchope Department Store, Port Macquarie Department Store and Laurieton Department Store, over the value of fifty dollars (\$50)
  - **4.1.2.** The docket or copy of the docket must have the person's name and phone number provided on the reverse at the time of purchase and placed in the entry barrel.
  - **4.1.3.** To win a prize the entrant must be in store at the time of the draw.
  - **4.1.4.** No further action needs to be taken

## 5. Drawing winning entries, notification of winners and claiming prizes

- **5.1.** All eligible and valid entries will be placed into an entry barrel at the specified times.
- **5.2.** One prize will be drawn on December 7, 2018 and the second prize drawn on December 8, 2018 at The Department Store Wauchope, 22 High Street, Wauchope NSW 2446 in accordance with section 5.1.
- 5.3. In circumstances where the draw cannot happen for whatever reason, the prizes will be drawn at 10am on December 10, 2018 at the Corporate Centre of Hastings Co-operative Limited, Level 1 9-13 High Street, Wauchope NSW 2446 in accordance with section 5.1.
- 5.4. The Winners of all prizes need to be present at the draw to claim the prize
- 5.5. All winners will be published online at www.hastingscoop.com.au on December 10, 2018.
- **5.6.** The winner of the prizes may claim their prize at the draw, or by arrangement with Hastings Co-op. The winner will receive the prize no later than 6 weeks after the draw.

## 6. Right to Re-draw if Prize is unclaimed

- 6.1. Winners must claim their prize within 3 months of being notified.
- **6.2.** If a prize is not claimed within 3 months of being notified, Hastings Co-op will take all reasonable steps to deliver the unclaimed prize to the winner. At the conclusion of 3 months, if the prize cannot be delivered, Hastings Co-op may re-draw the prize, subject to approval and any directions made by the Office of Liquor, Gaming and Racing.

#### 7. Prize Ineligibility

7.1. If an ineligible or invalid entry is drawn another entry will be drawn until an eligible and valid entry is drawn.

# 8. General Conditions

- 8.1. All eligible and valid entries will be included in the draw.
- 8.2. All prizes are non-transferrable, non-changeable and non-extendable and cannot be exchanged for cash.
- 8.3. Cigarettes and tobacco products including e-cigarette are excluded from this promotion.
