

## Co-op 100 terms and conditions

Earn points every time you shop at any of our Hastings Co-op businesses\*. It's as simple as presenting your Co-op 100 rewards card. Collect 100 points and receive a \$15 voucher (Valid for 6 months) to put towards you next Hastings Co-op purchase.

1. A valid Co-op 100 rewards card must be presented at the time of purchasing goods and must be swiped or scanned to accumulate points.
2. Bulk and commercial quantities of goods and services are excluded from the scheme. For ease of reference these include bulk fuel transactions, bulk fertilizer and seed transactions, tanks and commercial irrigation projects.
3. Points, or part there-of, are accumulated on every eligible transaction.
4. Once 100 points are accumulated the Co-op 100 rewards member is entitled to a rewards voucher to the value of \$15 which can be used at any Hastings Co business. The voucher is not redeemable for cash, and must be redeemed in one transaction,
5. Vouchers will have an expiry date of 6 months from the date of issue.
6. Points are accumulated at different rates depending on the Hastings Co-op business where the transaction occurs. As at the 1<sup>st</sup> January 2018 the points are accumulated as follows:

Liquor	30.00	1
Department Stores	12.00	1
Mitre10 & CRT Stores	25.00	1
Caltex Service Stations	40.00	1

7. Points are updated overnight so please allow 24 hours from the time of purchase for the points balance to be accurate.
8. Errors and omissions will be investigated at the discretion of Hastings Co-op.
9. Participation in competitions and promotions will be subject to the separate terms and conditions of the promotion and Co-op 100 rewards members should check these before entering.
